

Primary responsibilities of the office include preparing the state judicial system budget, organizing payrolls for judicial personnel and court reporters, assigning judges between circuits, collecting and publishing statistical information of case loads and case flow in the unified court system, and conducting in-service training for all judges.

### Clerk of the Supreme Court

The Clerk of the Supreme Court, appointed by the Supreme Court justices, records and files documents for Supreme Court cases, preserves court records, schedules cases for oral argument, notifies attorneys and interested parties of the disposition of matters coming before the Supreme Court, prepares mandates and final orders of the court and issues these mandates to the appropriate court or administrative agency, and maintains statistics.

The clerk also issues law licenses to attorneys newly admitted to the practice of law, keeps the roll of attorneys, and issues certificates of registration to law firms practicing as professional service corporations, professional associations, limited liability companies and registered limited liability partnerships.
