Attached is the **Dormant Judgment Certification form DSD SR 92**. To be eligible for this form, the judgment must have been filed in an Illinois court and seven years must have passed since the judgment was entered. Please follow the steps indicated below for completing the form.

1. Please print your full name (Name of Defendant), your Illinois Driver's License number, the Judgment Case number and the Date Judgment Entered in the spaces provided on the top of the form.
2. Please make certain that the information submitted is relating to the case that you are currently suspended on under the Safety & Financial Responsibility law. You may obtain this information by calling our office at (217) 782-3720 prior to visiting the Clerk of the Court.
3. Once the judgment identifying information is completed, you should then visit the court clerk in the county in which the case was filed. You should submit the form to the clerk and ask that they review your case to verify that your case is dormant. Once verified the court should then be asked to complete the remaining part of the form, affix the court seal or stamp and sign the attached form.
4. Please make certain the form is completed entirely before submitting to our office.
5. Mail the completed form to our address above (we do not accept faxed documents). Please allow 5 to 10 working days for processing, after the document has been received.
6. Please note that you are also required to file Proof of Financial Responsibility in the form of an SR22 Certificate of Insurance prior to driver's license reinstatement. Please contact your insurance agent regarding this requirement. If you no longer reside in Illinois, please review our web site for information regarding the "Out of State Affidavit Financial Responsibility Insurance Waiver."
7. You are also required to pay a \$70 license reinstatement fee to our office. You may mail your fee with this form by personal check/money order, or call (217) 782-3720 and pay the fee by credit card/debit card.
