

**AGREEMENT BETWEEN THE
ILLINOIS SECRETARY OF STATE
AND A
COMMERCIAL DRIVER'S LICENSE
THIRD-PARTY CERTIFICATION ENTITY**

BY AND BETWEEN the

ILLINOIS SECRETARY OF STATE

AND THIRD-PARTY CERTIFICATION ENTITY KNOWN AS:

This agreement authorizes the named Third-Party Certification Entity to administer commercial driver's license skill tests, on behalf of the State.

NOW THEREFORE, the Illinois Secretary of State and the Commercial Driver's License Third-Party Certification Entity named herein in the consideration of their mutual duties and responsibilities to one another herein after set forth, agree to the following:

I. THE THIRD-PARTY CERTIFICATION ENTITY AGREES TO:

- A.** Conform with all applicable statutes, Administrative Rules and regulations of the State of Illinois and the FHWA.

- B.** Indemnification
Indemnify and hold harmless the Illinois Secretary of State from and against all claim, losses, damages, costs and other proceedings made, sustained, brought or prosecuted in any manner based upon, occasioned by or attributable to any injury, infringement or damage arising from any act or omission of the Third-Party Certification Entity or their employees in the performance of this Agreement.

II. THE SECRETARY OF STATE AGREES TO:

A. Testing

Permit the above named Third-Party Certification Entity to administer commercial driver’s licenses skill tests as specified by the applicable statutes, Administrative Rules and regulations of the State of Illinois and the FHWA.

B. Administration and Enforcement

Administer and enforce the provisions of the applicable statutes, Administrative Rules and regulations of the State of Illinois and the FHWA as part of the agreement.

III. TERMINATION OF THIS AGREEMENT

This agreement reserves the right unto the State the right to take prompt and appropriate remedial action against the named Third-Party Certification Entity in the event the Third-Party Certification Entity fails to comply with the terms of this agreement.

IV. ENTIRE AGREEMENT

This document hereto constitutes the sole and entire agreement between the Illinois Secretary of State and the Third-Party Certification Entity relating to the authority to administer the commercial driver’s license skill tests. No other terms or conditions shall form a part hereof, and this agreement shall not be modified except by the subsequent agreement in writing and attached as an addendum, duly signed by the authorized representatives of both parties.
