**Enclosed is your renewal application for your Dealer/Re-
mitter License. Please read the following instructions for
completing the application and make
sure all information is provided to ensure the quick
return of your license.**

To ensure the delivery of your Certificate of Authority and license plates by January 1 of the upcoming year, your application must be received by the Secretary of State's office by November 15. If you have questions before submitting your renewal, please call the Secretary of State's Dealer Licensing Section at 217-782-7817.

All Renewal Applications

1. Your renewal application includes all the information the Secretary of State's office has on file for your license. If any information has changed, please call the Dealer Licensing Section at 217-782-7817.
2. Please answer all the questions, sign the application and **have it notarized**.
3. Enclose a check or money order for the appropriate fees (see Fee Schedule on back). The fee is automatically calculated when using the online Dealer Renewal System at www.cyberdriveillinois.com.

Dealer Applications (DL, DLT, DLM)

1. Include your Designated Agent Bond (if newly licensed in the past 60 months). This **MUST** be the original document – **no copies** please.
2. Include your Certificate of Insurance with the following coverages (not required for trailer dealers):
 - \$100,000 bodily injury/death per person;
 - \$300,000 bodily injury/death per accident;
 - \$50,000 property damage;
 - OR
 - \$350,000 combined single limit coverage.

The expiration date of the Certificate of Insurance **must** be December 31 of the license renewal year, or indicate **continuous until canceled**, and must be issued after August 1 to be a valid certificate. The certificate must have a policy number assigned; a binder is not acceptable.

3. The name and address for your business and any supplemental locations must be listed on the bond and insurance. The name and address(es) must match your application.
4. The number of sales for the previous year must be entered in the proper space. The Secretary of State's office cannot issue plates without a figure for calculation. Cross-reference the figure entered with the Fee Schedule on the back to determine the correct quantity of plates allowed.
5. Check your tax number. The Illinois Department of Revenue no longer mails a card each year. If your number has changed, please contact the Secretary of State's office for further instructions.

Example: If you sold 50 vehicles in the previous calendar year, you are entitled to one set of Master Dealer plates for \$45, plus a maximum of seven sets of Duplicate Dealer plates for \$13 each. (Schedule A reads M+7.) If you need additional license plates, you may purchase up to eight more sets at \$151 per set (see Schedule B).
