

## Secretary of State Police Mission Statement

The primary mission of the Secretary of State Department of Police is the regulation of businesses involved in the sale of motor vehicles and vehicle parts through enforcement of the Illinois Motor Vehicle statutes and the Secretary of State Administrative Rules and Regulations. The purpose of this regulatory function is the protection of consumers against fraudulent motor vehicle transactions throughout the state. The secondary mission of the department is to provide law enforcement services to all Secretary of State facilities, the State Capitol Complex and other law enforcement agencies.

## Investigator Trainee Qualifications

### Education and Experience

- Knowledge, skill and ability equivalent to the completion of high school and 60 semester hours of college credit, preferably with coursework in law enforcement, criminal justice, law, government or another related field.
- Equivalent training or related experience as a law enforcement officer or in the military police may be substituted for college credit on a year-for-year basis.

### Requirements

- Valid Illinois driver's license.
- Physical condition sufficient to pass and maintain a comprehensive physical examination.
- No criminal background.
- Successful completion of the Illinois Law Enforcement Training and Standards Board Basic Training Program.

## Investigator Qualifications

### Education and Experience

- Knowledge, skill and ability equivalent to the completion of high school and 60 semester hours of college credit, preferably with coursework in law enforcement, criminal justice, law, government or another related field, and one of the following:
  - Completion of the Investigator Trainee Program.
  - Completion of the Illinois Law Enforcement Training and Standards Board Basic Training Program.
  - Waiver from the Illinois Law Enforcement Training and Standards Board for Basic Training.
- Experience as a professional in municipal, county or state law enforcement may be substituted for college credit on a year-for-year basis.

### Requirements

- Valid Illinois driver's license.
- Physical condition sufficient to pass and maintain a comprehensive physical examination.
- No criminal background.
