



AFFIDAVIT IN LIEU OF NATURAL DISASTER DISCLOSURE STATEMENT

This form is *only* to be used by new vehicle dealers licensed under Section 5-101 of the Illinois Vehicle Code and rental owners as defined in Section 3-400 of the Illinois Vehicle Code (625 ILCS 5/3-400, 5-101).

Either a new vehicle dealer or a rental owner may affirm that a vehicle that was in area designated by the Federal Emergency Management Agency (FEMA) as a Natural Disaster or Hurricane-affected area has not sustained damage as result of the natural disaster or hurricane. Any new vehicle dealer or rental owner that affirms a vehicle is free from flood-related or other damage that may occur in such a natural disaster or hurricane, shall be liable to the Illinois buyer for any repairs, costs, damage or other related expenses an Illinois buyer may incur if the Illinois buyer relied on the new vehicle dealer or rental owner's affirmation that the vehicle was not subject to flood or other similarly related damage due to a natural disaster or hurricane.

This form may be used in lieu of a Natural Disaster Disclosure State (form VSD 694.5) for vehicles that are subject to the geographic area designated by FEMA. The Secretary of State's office reserves the right to request additional documentation and/or the right to verify through third-party systems the vehicles history to ensure that any vehicle subject to this process receives the appropriate brand designation on a certificate of title, if applicable.

I certify and affirm that the above vehicle **has not** sustained damaged related to a flood or hurricane-type event, or if the vehicle did sustain damage, then it was **less than 25 percent** of the value of the vehicle's fair market value.

In no circumstances, is this affidavit a warranty or affirmation that normal wear and tear for a vehicle of similar model year, make, or condition, or other mechanical, structural, or manufacturer recall is not present in this vehicle. A copy of this affirmation shall accompany any application for certificate of title on behalf of an Illinois buyer as confirmation that this form has been disclosed to the buyer prior to the completion of the sale of the vehicle.

I understand that this affirmation is only to be used when a motor vehicle is applying for title in Illinois and the vehicle was previously titled and registered in an area declared by FEMA to be a natural disaster or hurricane affected area.

I understand that I am making this affirmation under the penalty of perjury and that knowingly making a false representation on this form is punishable by law.
